Marijuana Ordinance Update: The board decided to hold a Special Meeting on Aug. 1, 2019 at 5:30PM at the Stanton Township Hall to hold a Public Hearing on the proposed Marijuana Ordinance. Kara will post the special meeting in three public places in the township, one being the Stanton Township website.

*It has been brought to the board's attention that we need a new lawn mower to mow grass at the N. Canal Park, the township hall and at the Liminga Fire Hall. The N. Canal Park caretaker's, the Purdy's, will make the purchase.

After Stan gave a lengthy recap of each project, Marvin motioned to hire Traverse Engineering Svcs. for Project#1 and #2, and to hire U.P. Engineers & Architects, Inc. for Project#3. 2nd by Lori. Approved Unan. Stan suggested that we get contracts for these engineering companies from other townships that have already done this. The price must be in the contract and Ken Vrana will get Marvin some sample contracts for Traverse Engineering Svcs and U.P. Engineers & Architects, Inc. Stan said it is a priority that Project#1 and Project#2 must be done asap, with the deadline being the end of this year.

Freda Sewer Update: All is well. Sewer is doing A-OK!

N. Canal Park Update: It was brought to the boards attention that we need a "NO CAMPING" sign at N. Canal Park immediately, as people are taking it upon themselves to camp there illegally as it is only a day park! Marvin will order two signs stating "NO CAMPING" and get them up at the park as soon as they come in. The electric meters are already turned off and there is no existing electricity there right now. A year from now UPPCO will remove the box permanently, unless advised otherwise.

Houghton County Jail Committee Update: Per jail committee member Glen Ekdahl...The committees toured proposed jail site Camp Kitwin and the existing jail. There is also an empty lot across the street from the existing jail and an empty lot near Walmart that is an option for a new jail site, plus the proposed add on to the existing jail. The search for a new jail is ongoing. The next meeting will be held on Sept. 4, 2019.

Agate Beach Park Update: There is rebar sticking out of the concrete in the water on the boat ramp at Agate Beach Park. John will check with park caretaker Lenny Luoma, and if possible, he will have him use the same person to cut it out as he did last time. If this isn't possible he will let the board know.

Redridge Dam Update: Per John Paul Pietila...Traverse Engineering Svcs is in charge of the first two projects at the Redridge Dam and John Paul met with Stan Vitton to go over both projects. We need to establish a property line, merge the roads and remove debris. They will have a walk through with contractors vying for the job and they will pick the best optioned contractor. The job must be done before winter. If we end up needing more FEMA money we can ask for more. As far as debris goes, they will remove it to high ground and leave it there with township approval.

Fire Dept. Pct#1 Update: Per Fire Chief Mike Pionke...The excavation for the training building is almost complete and the slab should be poured with two weeks. The money the dept. receives from topsoil sales will go to the

General Fund. Hat's off to Greg S. for passing the National Registry for 1st Responders as he is now a medical first responder!

*Kara mentioned that a computer update is needed for QVF on her computer and Mary's. Mary said the man who will do the updates will come to do it within the next couple of weeks.

The Transportation Asset Management Council(TAMC)will come to the township to give a presentation in January if the board is interested. The presentation will last roughly 2.5 hours. Freda Sewer Update: Per operator Jim Morin...the sewer is working well. A camera survey was done and there were no structural breaks. No bill for the survey has been sent so far.

*It was also mentioned that there are a few manhole covers in Freda that were wrecked by the county plow that need fixing as they are a hazard. Marvin will call the Road Commission/Kevin Harju to discuss this issue.

Next the board heard from Linda Hanson, an engineer from the State of Michigan Dept. of Environment, Great Lakes & Energy, Water Resources Division, who came to give the board a presentation on how flood insurance works. The board will further educate itself on this subject for future reference.

Redridge Dam Project Update: Per Stan Vitton...The debris has been removed and phase 1 & 2 project requirements have been completed by the John Coponen Construction Company. If we feel that additional work is required, we can apply for more money and an extension(6 months). Stan emphasized that the water must go through the pipes at the dam and not through the spillway. Stan said that he and Ken will talk to the proper people about this issue. Next is phase 3. According to Stan, the Houghton County Emergency Management Plan needed updating and was drafted already. If accepted by FEMA, there will be more money for the Father's Day Flood damages.

Township Board Future Meeting Dates: The Stanton Township Board set their regularly scheduled board meetings for the year. They will be the 2nd Wednesday of every month at 6PM at the Stanton Township Hall. However, the two exceptions are the May meeting which will be held at the Toivola Rec Center and the September meeting which will be held at the Agate Beach Park Pavilion. The Board will host a 2020 Transportation Asset Management for Local Officials seminar on Tuesday, January 14 at 9AM at the Stanton Township Hall. The Board will hold the Budget Workshops on Wednesday, January 15th & 29th at 5PM at the Stanton Township Hall. And finally, the annual Truth & Taxation & Truth in Budgeting Meeting will be held on the same day as the monthly board meeting on Wednesday, February 12th and will be at 5:30PM.

Liminga Fire Dept. Pct#1 Update: Per Fire Chief Mike Pionke...Fire School will be starting at the Liminga Fire Hall in January. Mike <u>motioned</u> to <u>amend</u> the Fire Dept. Pct#1 Budget(each board member received a copy of budget amendments by email). <u>2nd</u> by Lori. <u>Approved Unan</u>.
