

## **Bid Agreement to Perform Plowing Services to Stanton Township**

### **Period of Performance**

The Services shall commence on Nov 01, 2023, and shall continue through May 01, 2024.

All bids will be received, opened and read at the regular monthly board meeting of Stanton Township Board. Oct 04, 2023 @ 6:00 pm. The lowest, correct per/time bid total shall be awarded this contract.

Stanton Township board reserves the right to accept or reject any/all bids.

### **Scope of Work**

- Contractor shall keep open and accessible, by plowing or otherwise, the following Stanton Township Facilities described below.
- Contractor shall provide proof of Liability Insurance to Stanton Township Clerk upon request. Failure to provide proof of Insurance shall be just cause for contract termination.
- This agreement and rates quoted shall also include a 1 (one) time removal/pushback of snow banks created by the plowing services, (as needed as determined by the Township Treasurer) for each 200" of snow recorded at the Houghton County Road Commission in Ripley. No additional compensation shall be made for this. It is included with the total hourly rate.

### **Contractor Responsibilities**

Contractor shall keep all Stanton Township facility doors generally free of snow and snow/ice buildup according to the Fire Chiefs approval for the Fire Stations and the Township Treasurers approval for the Township Hall and Kenner Dome for the duration of this contract period.

This includes the following facility/locations:

1. Stanton Township Hall, both main doors.
2. Precinct #1, Firehall, Overhead Truck Doors
3. Redridge Firehall, Overhead Truck Doors
4. Kenner Dome, Main door and Fire Exit
5. Stanton Township Fire Training House site shall be kept free of snow/ice buildup as per agreement with the Precinct #1, Township Fire Chief.
6. Stanton Township Carpool Lot (across from Precinct #1 Firehall)
7. Aggregate Parking lot at Redridge Dam

## Township Payment Responsibilities

Stanton Township shall pay monthly, after Invoice is submitted to the Twp Clerk, and immediately after Township Board approval, all plowing incurred by the Contractor for the month.
